There are three side events that you are entered in free just by sending in your one low entry fee of \$50 – they include a Prettiest Eyes Award, Prettiest Smile Award and a Prettiest Hair Award in each age division. Winners of each side award will win a certificate. If you have any questions, contact the director.
